

ASC Holds Successful Team Weekend

Your ASC Board of Directors, chapter representatives and other committees met over the weekend of March 20 and 21, 2004 at the Doubletree Hotel in Sacramento. The two day series of meetings was a whirlwind of activity and many of the goals identified in our 2004 Long Range Strategic Plan have been accomplished already and we are barely at the end of the first quarter.

The ASC Insurance Services Management Committee met on Saturday to review progress in the program and to discuss the coming year. Thanks to all the additional board members and other members who joined us for this meeting and for the interest being shown in the program. We are happy to announce that we continue to show growth and financial stability and are working on doing different kinds of marketing including developing outreach programs both in the chapters and to the membership at large to continue building your association owned agency. If anyone has any ideas on how ASCIS can be of service to your chapter, please contact Shelly Levy of the ASC staff at (916) 924-9054 and we will take those suggestions to our monthly ASCIS Management meetings.

ASC Committees met after lunch and a lot of good work is being done. The Government Affairs Committee chaired by Carol Bartels has a full meal on its plate this year. With the continued battles over the workers' compensation insurance system, our participation in the 17200 ballot initiative, continued encroachment by the CARB on upping warranties again, the BAR Sunset Review Process which has not concluded yet and many other barn burners, this year portends to be quite tumultuous legislatively. The Government Affairs Committee voted unanimously to continue supporting HR 2735, the Consumers Right to Repair Act currently seeking congressional approval and supported by a broad coalition of automotive aftermarket associations and interests. This grandfather bill of SB 1146 will require manufacturers to provide repair information not just for OBD II systems, but vehicle wide and will provide appropriate enforcement measures should they choose not to do so. ASC members will benefit from this much in the same way they benefit from OBD II information and in fact, California's success with SB 1146 and the strong support given by the industry to that really did make HR 2735 possible.

The Membership Committee chaired by Kevin Browning continues to look at membership recruitment and retention strategies and has come up with several plans to do both this year. They are also in the process of approving our Marketing and Communications Plan which includes provisions for getting the message out to both other industry publications and the consumer regarding ASC and what we stand for which is quality, professional automotive care that is dedicated to the needs of the California consumer. We will also be doing a Membership Drive 2004 and the chapters will be contacted with more information on how they can participate as soon as the final plans are developed. Our Membership Survey 2004 is going to be another great project as we continue to ask YOU what you think about things. With input from the Education, Training and Information Committee and other sources we are preparing the survey which will come out around June. Please keep an eye out for it and participate because hearing from you is one of our most important goals.

Speaking of the Education, Training and Information Committee chaired by Glenn Davis, they are a busy group this year. In addition to pitching in with ideas for the website, and developing FAQs (frequently asked questions) to address

The second is ASC Policy 2-17 Conflict of Interest, the purpose of which is to set policy regarding the definition and handling of potential conflicts of interest within ASC-CA. The policy regarding elections is still under revision but is due to be complete by the June Board of Directors meeting.

Our Endorsements Committee chaired by Greg Kelly is looking at some new things to benefit our membership such as looking at endorsing a Legal Resource Manual that we can make available to the membership. More information will be forthcoming on that project. We've reaffirmed our endorsements of CustomerLink and also of ALLDATA as we believe they provide valuable member services to our members. The committee recommended, and the Board of Directors concurred, to terminate our endorsements of iCARumba, First Corp and Certegy Check Services. More information about this can be found in a separate article in this issue of the California Independent.

The next day was eventful as the Chapter Representatives Committee met

Ira Newman to get involved with their local communities in community service activities such as the 4th Annual Cheryl MusscheWalk Against Cancer on April 17, 2004 that Chapter 48 is actively promoting. - 1. **Prepare!** Expect the unexpected. Make sure your employees are aware of your emergency action plans and keep necessary information posted in an area that is prominently visible.
- 2. **Identify** the hospital, doctor or clinic that will provide medical treatment and decide how injured employees will be transported to that facility.

Injured employees should not drive themselves. Call 911 if the employee is bleeding profusely, is unconscious or is having a heart attack. (note: An employee can pre-designate a physician before an injury occurs. If an employee pre-designates a treating physician then ensure there are means of transporting them to this doctor.)

- 3. Advise employees that they can return to work after an injury to perform modified or light-duty work if it is available. Tell employees to advise the medical provider that light-duty is available.
- 4. **Report** the injury to your workers' compensation insurance carrier soon after you are assured the employee is receiving medical treatment. Report the injury even if it just a first-aid injury. California law requires employers to report within 5 DAYS of knowledge of every occupational injury or illness that results in lost time beyond the date of the incident or requires medical treatment beyond first aid.
- 5. **Remove and Preserve** faulty machinery, equipment or tools from service as evidence.
- 6. **Stay in frequent contact** with the injured employee and your workers' compensation insurance carrier during the course of the claim.

industry issues that are on the horizon including a possible 250,000 mile warranty program out of the CARB. Aaron

Lowe from AAIA gave a presentation on HR 2735 and the fact that we have been successful in getting a companion bill to HR 2735 introduced in the Senate as well (S.2138). Continued industry

unity and support is critical to getting this legislation enacted which will ensure that independent automotive repair facilities gain the access to the information and tools they need in order to repair vehicles.

The Job Killer Reform Panel was a lively discussion regarding a number of issues that continue to loom large. Workers' compensation insurance reform continues to absorb a lot of attention in the Governor's Office and Legislature. If they are unable to reach some sort of compromise and enact meaningful reform then the ballot initiative will be the fall back position. Initiative petitions were sent out to ASC members by mail and we also had petitions there for people to sign. The ballot initiative for 17200 reform continues to gain steam and has received enough signatures to qualify for the November ballot. The campaign continues to depend on support from ASC members. Thanks to all of you who returned petitions to ASC and all those that we were able to name as we go to press are listed elsewhere in this issue of the Independent. If we weren't able to include your name, please know that we thank you too! Check in on www.stopshakedownlawsuits.com for information regarding the campaign.

SB 2 (Burton), the mandated health care bill, is still a hot-bed issue. There is a movement to have a referendum placed on the ballot in November to overturn this one as well. SB 2 is a \$5.7 billion tax on employers and a \$1.5 billion tax on workers, who would be forced to pay a share of healthcare coverage whether

California would become one of only two states with such a mandate giving businesses even more reason to lay off workers, close their doors or move to other states. To learn more



Put a Nice-Looking Model in Your Shop!

Life has become much harder for most shop owners; the money and the fun are gone. You're working harder to just stay even. Things that used to work now don't. Blame is put on everything from rising costs to the complexity of today's cars. The truth is that there is more money spent on auto service today than ever before and you compete with onehundred thousand fewer shops. So why is the business so hard today? The answer is: You have the wrong business model.

Every business, auto repair shop or computer manufacturer, embodies a business model within it. A business model is the operational framework that defines a business. Within a business model is a financial model (how you charge, how much you charge, what you spend and what should be left over for you). There is a marketing model (how you get customers, what type of customers you need and how you keep them). There will also be a sales model, an operations model and a few other component models.

Let's imagine its 1980 and you run one of the finest typewriter repair businesses in California. Your techs can make an IBM Selectric sing and your customers just love you. Your business model has been serving you for years; you advertise in a business publication, do great work for a fair hourly fee and parts mark up, you have a few large accounts and lots of small ones, you keep your techs trained and you make a fair profit in addition to your salary. Good model, good business, good life. But where will you be in 2004? Probably gone. Why? Because you didn't change your business model as the world changed around you.

The epicenter of change for independent shop owners is the increasing reliability of cars. A 1980 car had about 110 repairs required per 100 cars per year. A 2003 domestic model has 18 repairs required per 100 cars!

Of nearly equal impact are the rising service expectations of today's customer. Both husband and wife work in 74% of American households. Women buy 58% of all auto service today and an even higher percentage of the maintenance work.

There is good news: there is more total auto service work available today than in 1980, it's just not mostly repair work anymore. Even better, today's car owner is willing to pay for convenience like never before. However, success in this new environment requires new skills and different business processes operating within a different business model.

It's not new news that you should sell more maintenance work and most shops have made some progress. However, most shops have only taken the first step of many required to "re-engineer" their shops to a maintenance based model that can make real money. Business Group Proposes Workers' Compensation Reform Initiative for November Ballot

The Small Business Action Committee, a business advocacy group that sponsored budget-related rallies held by Gov. Arnold Schwarzenegger (R) last month, has proposed including an initiative on the November ballot that would mandate several of the governor's cost cutting proposals for the state workers' compensation system, the Sacramento Bee reports. The initiative would reduce workers' compensation costs by as much as \$10 billion annually, according to the committee, which is affiliated with the 38,000-member California Small Business Association (Kasler, Sacramento Bee, 1/3).

As part of his "California Recovery Plan," Schwarzenegger in November proposed cutting up to \$11.3 billion in funds from the state's \$29 billion workers' compensation program, under which employers pay \$5.85 per \$100 of payroll — the highest rate in the nation — for coverage. Schwarzenegger's plan includes measures that would prohibit workers from receiving multiple disability payments for the same injury; require dispute resolution more frequently to reduce litigation costs; limit penalties paid by insurers and employers in medical bill disputes; and establish uniform standards for permanent disability (California Healthline, 11/19). According to the Bee, Schwarzenegger could pursue a ballot initiative on workers' compensation reform if the Legislature does not approve his proposal. However, while the "threat" of a ballot initiative could give Schwarzenegger negotiating leverage, the state workers' compensation system "may be too complicated and esoteric for the average voter to understand," the Bee reports. In addition, other groups, such as trial attorneys or labor organizations, "may wage expensive counter initiatives, further confusing the electorate and, in the end, throw the workers' compensation system into deeper chaos," according to the Bee (Chan, Sacramento Bee, 12/28/03).

ASC will keep you up to date on developments surrounding this issue.



Included in the plan are: working with states to implement more stringent air quality standards; cutting diesel emissions by finalizing the nonroad diesel rule; implementing the Clean School Bus initiative; applying consistent and certain enforcement to motivate compliance; and making enforcement decisions using multiple factors, including available resources and desired environmental benefits.

ASC will continue to monitor their efforts and will report on any impact on our membership.


